In future, when the Company publishes any Corporate Communication on the Websites which excludes any Corporate Communication that seeks instructions from you on how you wish to exercise your rights or as the shareholders ("Actionable Corporate Communications"), it will only send to you a notification letter that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a valid email address) or by post (if you have not provided an email address or the email address is invalid) at your address as it appears in the Company's register of members maintained by the Hong Kong Branch Share Registrar.

In the event that you have not provided your email address or the email address provided by you is invalid, the Company shall send the Actionable Corporate Communication in printed form together with a Reply Form for soliciting your valid email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.
